Friday from 10 a.m. to 6 p.m. except Friday, November 17 from 9 a.m. to 4:30 p.m. I have also appointed Mr. Charles-André Goulet, as my deputy, to receive these nomination papers.

- If more than one candidate runs for the position of mayor of the borough of L'Île-Bizard-Sainte-Geneviève, voting will take place on Sunday, December 17, from 10 a.m. to 8 p.m. An advance poll will be held on Sunday, December 10, from 12 p.m. to 8 p.m., to elect one candidate. Other special measures are planned to facilitate the exercise of voting rights. Learn more.

Sole owners and sole occupants who wish to withdraw an existing entry from the list of electors must send a signed written request to this effect to the Returning Officer by email at elections@montreal.ca or by fax at 514-868-4935, a written document signed to this effect, no later than November 14, 2023 at 4:30 p.m.

**NOTICE** is also given to **undivided co-owners of a property and to co-occupants of a business establishment** who are not already entitled to be entered on the list of electors as domiciled persons as sole property owners or as sole occupants of a business establishment, that they must meet the following conditions in order to be entered on the list of electors of Ville de Montréal:

- 1. Be age 18 or older on December 17, 2023;
- 2. As of **October 30, 2023**, be a natural person, a Canadian citizen, not under curatorship, and not

convicted of an offence constituting a corrupt electoral practice;

- As of October 30, 2023, have been an undivided coowner of an immovable property or co-occupant of a business establishment located within the abovenamed territory in the City of Montréal for at least 12 months;
- Have been designated by means of a proxy signed by the majority of co-owners or co-occupants who are qualified electors as of **October 30, 2023**;
- 5. Have sent this proxy to the Returning Officer, by email at elections@montreal.ca or by fax at 514-868-4935, which must be received no later than November 12, 2023 at 4:30 p.m.

Co-owners and co-occupants who wish to replace an existing proxy must submit a new proxy to the Returning Officer at **elections@montreal.ca or by fax at 514-868-4935**, which must be received **no later than November 12, 2023 at 4:30 p.m**.

**TAKE NOTICE** that any application for registration, withdrawal or proxy sent **after November 14, 2023 at 4:30 p.m., but no later than November 28, 2023 at 6 p.m.**, the last day for submitting an application to the Board of Revisors, will be considered as an application for a change to the electoral list and, consequently, will be forwarded to the Board of Revisors.
