Draft by-law on electoral districts Notice to Montréal's electors

Object of by-law

At its meeting of March 18, 2024, city council adopted by resolution the draft by-law titled Règlement sur les districts électoraux (by-law on electoral districts).

This draft by-law announces the city's intention to establish the boundaries of its 58 electoral districts to ensure a balanced distribution of electors and to comply with the Act respecting elections and referendums in municipalities (CQLR, chapter E-2.2).

This draft by-law concerns the geographic limits of the electoral districts. Its scope and intention do not therefore affect governance, the electoral framework or the way the population is represented in the city's boroughs and bodies.

Objection to the by-law

In accordance with section 17 of the Act respecting elections and referendums in municipalities (CQLR, chapter E-2.2), any elector may file an objection to the draft by-law within fifteen (15) days of the publication of this notice.

Every objection must be addressed in writing to M^e Emmanuel Tani-Moore, city clerk. Objections related to boundaries between districts must be submitted no later than April 10 at 4:30 p.m.

Persons wishing to file an objection may do so by one of the following means:

If at least 500 objections are submitted within the prescribed timeframe, the council will hold a public meeting to hear the persons present in accordance with section 18 of the Act respecting elections and referendums in municipalities.

Right of objection and validity

To be valid, every objection must be filed by a person qualified to vote in Montréal, which means that the person must:

- Be entered on the permanent list of electors of Élections Québec as a person domiciled in Montréal.
- Be entered on the list of electors of Montréal as the owner of an immovable or as the occupant of a business establishment.

To be valid, every objection must also bear a legible statement of the person's last name and first name as well as the address of the person who is filing the objection. Persons registered on the list of electors as non-domiciled must state the address for which they possess this qualification

Objections must be dated and submitted (see the Objection to the by-law section) no later than April 10 at 4:30 p.m.
